## **1. Introduction**

1.1 The terms contained herein to the LoanMart \$500 Extra Cash Promotion offered by Wheels Financial Group, LLC dba LoanMart ("LoanMart") form a legally binding agreement between You and LoanMart and can only be amended with LoanMart's consent. ## **2. Promotion Period**
